I, Mohammed Pasha S/o.Mohammed Babu Miya, Aged about 34 years Occ: Business R/o.H.No.5-194/145/1, Rajivgandhinagar, Church Gagillapur, Dundigal Gandimaisamma Mandal, Medchal – Malkajgiri Dist, submit the following few lines for your kind consideration and necessary action.

I most humbly submit that I am the owner and possessor of house premises bearing No. 5-124/137/Part (South side part) with a built up area of 100 Sq.feet of A.C.C.on a land admeasuring 125 Sq.yards or 104 Sq.meters (South part) of House bearing NO.5-194/137/Part (North Side Part) with a built up area of 100 Sq.feet and land admeasuring 15 Sq.yards or 12.5 Sq.meters out of 125 Sq.yards, thus total plinth area of 200 Sq.feet of A.C.C. on a total land admeasuring 140 Sq.yards or 117.04 Sq.meters out of 250 Sq.yards Situated at in Gramakantam of Church Gagillapur Village, Dundigal Gandimaisamma Mandal and Municipality, Medchal – Malkajgiri District.

I further submits that I purchased the above said property from my vendors Smt. Sandilya Seema Sharma W/o. Sandilya Santosh Sharma and others under a Registered Sale Deed bearing Document No.10930 of 2022 dt: 08-04-2022 registered in the office of S.R.O. Quthbullapur for a valid sale consideration



and on the date of registration itself my Vendor handed over the physical possession of the said property to me, since then I am residing in the said premises along with my family members and to the knowledge of one and all in the locality.

I further submits that on 16-12-2022 the police Dundigal came to my house stating that my brother by name Shaik Ahmed committed murder of one Ramesh and he was absconding and the police Dundigal demanded me to inform them where about the said Shaik Ahmed, on that I also assured the police Dundigal that I will inform if my brother makes any calls to me, accordingly the Police Dundigal left the place and thereafter the villagers by names 1.Ravi S/o.Not known, Aged about 35 years Occ: Coolie 2. Not known, Aged about 28 years Occ: Coolie 19.Durga W/o.Not Known, Aged about 33 years Occ: Coolie and others All are R/o.Rajivgandhinagar Colony, Church Gagillapur Gandimaisamma Dundigal Mandal, Medchal - Malkajgiri District, came to my house on 17-12-2022 at about 11-00 A.M.to 11-15 A.M. with shovel (gaddapara) and gun (pedda suthhe) and high handedly started demolishing the house with the help of the said gaddapara and pedda suthee and even they broke open the lock of other room and taken away the house hold articles and cash of Rs.30,000/- of the tenants who residing in the one of the family portion in the said house and when my wife tried to stop them, then they manhandled her and they dragged her from the house and they beat her with stones and after knowing the same I rushed to the spot and tried to stop them, then they threatened me and my wife stating that they will do away, if we try to stop them, on that they thrown away me and my wife and high handedly they have demolished two rooms and even they have taken away the house hold articles which were kept in the said rooms and even one Mahalaxmi taken away the brief case which contains the original documents pertaining to the land of Vishwanathpur, Thandur, R.R.District, on that I made a telephone call to the police Dundigal and informed about their illegal acts, on that the some police constable of Dundigal P.S. came to the spot and tried to stop them, but they never stop and they have totally demolished two rooms in the said house premises and thereafter they



started threatening me stating that they will demolish the entire house premises if he refused to transfer a part of the house in the name of the family members of deceased Ramesh, as there is no other go to me, I constrained to sign on a bond paper on the force of the above said persons, even one Sub Inspector of Police P.S.Dundigal Mr.Prabhakar Reddy also forced me to sign on Bond paper which was brought by them. I submit that even they destroyed the chicken centre and mechanic shop of my uncle by name Abdul Sattar high handedly as he is my relatives herein, the photographs and the video recordings of the above said illegal acts of them is herewith filed.

Hence, I request to your Kind authority, may be pleased to take necessary legal action against the said persons as per law.
