Facts of the case are that on 14.08.2022 at 1400 hours received a written complaint from Sri. Madagari Sugreevudu S/o. Venkata Ramulu, Age: 33 yrs, Caste: Mudiraj, Occ: Reporter, R/o. H.No. 01/113/379, Pochamma Basti, Devendra Nagar, Gajularamaram, Quthbullapur Mandal, Medchal Dist, in which he stated that on 13.08.2022 evening around 1800 hours when he was in his office at on Road no. 07, Venus Rock Hights Colony, Gajularamaram he got information about a quarrel occurred at Government land, Survey No. 342 on Road No. 01 of Venus Rock Hights Colony, Gajularamaram. So when the complainant went there to cover the news as part of his duties they fighting with his colleague Journalist Yellampalli Narsimhulu, Age: 34 years to stop recording videos, so the complainant tried to stop the fight. Then a person by name Sai along with 5 others has abused the complainant and his colleague using filthy language and punched with fists and also threatened by saying that they will kill them. They took the phones and detained them in a room and threatened that they will kill them along with their family members if they speak about them anywhere outside. Sai along with 5 others had threatened the complainant and his colleague. Therefore, complainant has requested to take necessary action. Hence the FIR. (The original complaint is enclosed herewith)

As per the contents of above complaint registered a case in Cr No. 669/2022, U/s 341, 504, 323, 506 r/w 34 IPC and investigation entrusted to Sri. Arthi Hareesh-SIP.
